




United Infrastructure Group 100 Year Timeline

THE FIRST BRIDGE SC 9 over Catawba River

Three Generations of Bridges

"This unique SC 9 over Catawba River bridge honors three generations of Chester County Bridgebuilders from Fredrick Amzi Triplett, in 1926, to James T. Triplett in 1975 and to James E. Triplett in 2017. "John E. Davis

The history of the construction of the bridges carrying SC Hwy 9 over the Catawba River at the Chester/Lancaster County line in Fort Lawn, SC is a unique, multi-generational story in the history of South Carolina and the bridge building industry in the southeast.

In 1924, F. A. Triplett, Sr., (a native of Chester, SC) partnered with R. H. Small to form Small & Triplett Construction Co. in Chester, SC. That same year, they were awarded their first contract with the then South Carolina Highway Department to build a new two-lane bridge to carry SC Hwy 9 over the Catawba River. This riveted steel beam structure was completed in 1926 and replaced a ferry that carried automobiles across the river. F. A. Triplett, Sr. passed away in 1962 with recognition from his contemporaries as a pioneer in the bridge construction industry and a man of great integrity.

50 years later in 1975, his son, James T. (Tom) Triplett of Triplett-Ryan, Inc. (also a Chester native), completed a second parallel bridge across the Catawba River for the South Carolina Department of Highways and Public Transportation. At that time, the original 1926 bridge was reconfigured to carry two southbound lanes of traffic while the new 1975 bridge was designed to carry two new northbound lanes of traffic between Chester and Lancaster counties. Of note is that of the attendees at the dedication of the new southbound bridge in 1976 to F. A. Triplett, Sr. included F. A. Triplett, Jr., and James E. Triplett, the 11-year-old son of James T. (Tom) Triplett, who would follow in his father's and grandfather's footsteps. Tom Triplett passed away in 1992, and, like his father, he was respected by his contemporaries for his contribution to the construction industry.

James E. (Jim) Triplett carries on the legacy of his father James T. (Tom) Triplett, his uncle Fred A. Triplett Jr, and his grandfather Fred A Triplett, Sr, and united the prior bridge building companies into a single successful design-build group still headquartered in Chester County. In 2015, some 90 years after the original bridge contract was completed and 40 years after the subsequent bridge contract, Jim Triplett of United Infrastructure Group, Inc. was awarded a contract by the SCDOT to design and build a new bridge to replace his grandfather's 1926 southbound bridge across the Catawba River beside his father's 1975 northbound bridge. The 90-year-old riveted steel beam bridge was demolished in 2016 and the new precast concrete beam bridge was completed in 2017.









THE RICHES OF HIS GRACE

For you know the grace of our Lord Jesus Christ, that though He was rich, yet for your sakes He became poor, that you through His poverty might become rich (2 Corinthians 8:9).

Who could possibly estimate the riches of God?

In Psalm 50:10, He tells us, "Every beast of the forest is Mine, and the cattle on a thousand hills." But that is just to give us a picture we can understand. The truth is, the whole universe and everything in it belongs to Him. And if that weren't enough, He is able to speak a billion more universes into existence, just by His word. Bridgeway Station, Greenville CAGC CONTRUCTION EXCELLENCE AWARD







This design build project consisted of building a pedestrian bridge over I-385 in Greenville County to connect a larger development project for the city of Mauldin, Bridgeway Station, to a portion of trail that will be connected to the Swamp Rabbit trail. The structure is a four span, 360' long, 15' wide pedestrian bridge consisting of box beams and cored slabs. The two end bents are integral abutments sitting on four 14x73 piles. The eastern end bent required a Forix retaining wall developed by Earth Wall Products to accommodate the required traffic clearance on I-385 and a larger pedestrian plazza leading to the development. UIG designed and installed a custom fabricated metal fence across I-385 to protect the pedestrian traffic and hand formed an architectural concrete rail on the outside spans and around the plazza. The project also included a short extension of the future Swamp Rabbit Trail, connecting the bridge to the existing portion of trail and allowing access to the bridge from the City of Mauldin.

2002: US 221 Columbia County, Georgia









UIG has closed out a project in Columbia County, GA which included ramps, roundabouts, and a bridge over I-20 along US 221.

US 1 over Altamaha River, Toombs





This Design-Build project includes 9.403 miles roadway reconstruction on US 1/SR 4 beginning south of SR 147 at Plant Hatch and extending south of George Hill Road with 238,425.00 SF of new bridges over the Altamaha River and four additional creeks. UIG is selfperforming all structures, which includes construction of five new bridges: 4,080' x 41-3" bridge over the Altamaha River with four total bents of drilled shafts: two 6' diameter x 152' deep and six 6' diameter x 116' deep drilled shafts with column and cap substructures supporting Mod Bulb Tee 72" (6' tall by 2'-2" wide) prestressed concrete beams; two total bents of 14" x 102 steel H pile footer bents with column and cap substructures supporting Type III (3'-9" tall by 1'-10" wide) prestressed concrete beams; eight total bents of 16" prestressed concrete pile footer bents with column and cap substructure supporting Type III prestressed concrete beams; and 44 total bents of 16" and 20" prestressed concrete pile with cap substructures supporting Type II (3' tall by 1'-6" wide) prestressed concrete beams; 600' x 41'-3" bridge with six bents of 18" prestressed concrete pile foundations and cap substructures supporting Type II prestressed concrete beams; 380' x 41'-3" bridge over Williams Creek with eight bents of 18" prestressed concrete pile foundations and cap substructures supporting Type I Mod (2'-4" tall by 1'-6" wide) and Type II prestressed concrete beams; and two 360'x 41'-3" bridges over Cobb Creek each with five bents of 16" and 18" pipe pile foundations and cap substructures supporting Bulb Tee 54" (4'-6" tall by 2'wide) prestressed concrete beams. UIG is utilizing their extensive fleet of sectional barges to install a 41' wide causeway with fingers from the southern river bank to provide uninhibited construction access during the moratoriums and fluctuating water elevations.

2108: US 76 over Lynches River, Florence County, SC







This Bid-Build project includes a new structure over the Lycnhes River and adjacent flood plains and removal of an existing structure along the US 76 corridor which is a main travelway from Sumter, SC to Florence, SC. The new structure replaced a 900' long structue with a replacement bridge that is 1,302' long x 47.25' wide with two 12' lanes and 10' shoulders. The end bents consisted of 54" diameter cased drilled shafts. All interior spans included 84" diameter cased drilled shaft foundations with concrete columns, and cap substructures supporting 129' Long 72" Modified Bulb Tee Beams. The superstructure consisted of cast in place concrete intermediate diaphragms, end diaphragms, along with cast in place decks. The approach roadways were raised 6' and widened to accommodate safer shoulders and new curb and gutter sections througout the project along with a new river access road that was constructed and paved down to the river's edge. UIG utilized their fleet of sectional barges and steel mats to install a 35' wide causeway with fingers from both river banks to provide uninhibited construction access regardless of weather conditions. Sectional barges were also utilized for floating crane rig platforms, drill rig platform, and material storage platforms. This approach to construction access allowed work to proceed with a continuous supply of material to facilitate completion of the project within the aggressive project schedule. 




